

Web privacy policy

Oxygen Service Company respects your privacy and is committed to protect the personal information that you share with us. Generally, you can browse through our website without giving us any information about yourself. When we do need your personal information to provide services that you request or when you choose to provide us with your personal information, this policy describes how we collect and use your personal information.

Information Collection

Personal information means any information that may be used to identify an individual, including, but not limited to, a first and last name, email address, a home, postal or other physical address, other contact information, title, birth date, gender, occupation, industry, personal interests, other information when needed to provide a service you requested. When you browse our website, you do so anonymously. We do not collect personal information, including your email address. We do log your IP address (the Internet address of your computer) to give us an idea of which part of our website you visit and how long you spend there. But we do not link your IP address to any personal information.

Oxygen Service Company collects personal information when you use certain Oxygen Service Company products or services, when you ask to be included in an email or other mailing list, or when you submit your information to Oxygen Service Company for any other reason. From time to time, Oxygen Service Company receives personal information from business partners and vendors. Notice

When personal information is collected, we will inform you at the point of collection the purpose for the collection. Oxygen Service Company does not intend to transfer your personal information to third parties without your consent, except under the limited conditions described under the discussion entitled Information Sharing and Disclosure below. If you choose to provide us with your personal information, we may transfer that information, within Oxygen Service Company or to our third party service providers.

How We Use Information Collected
